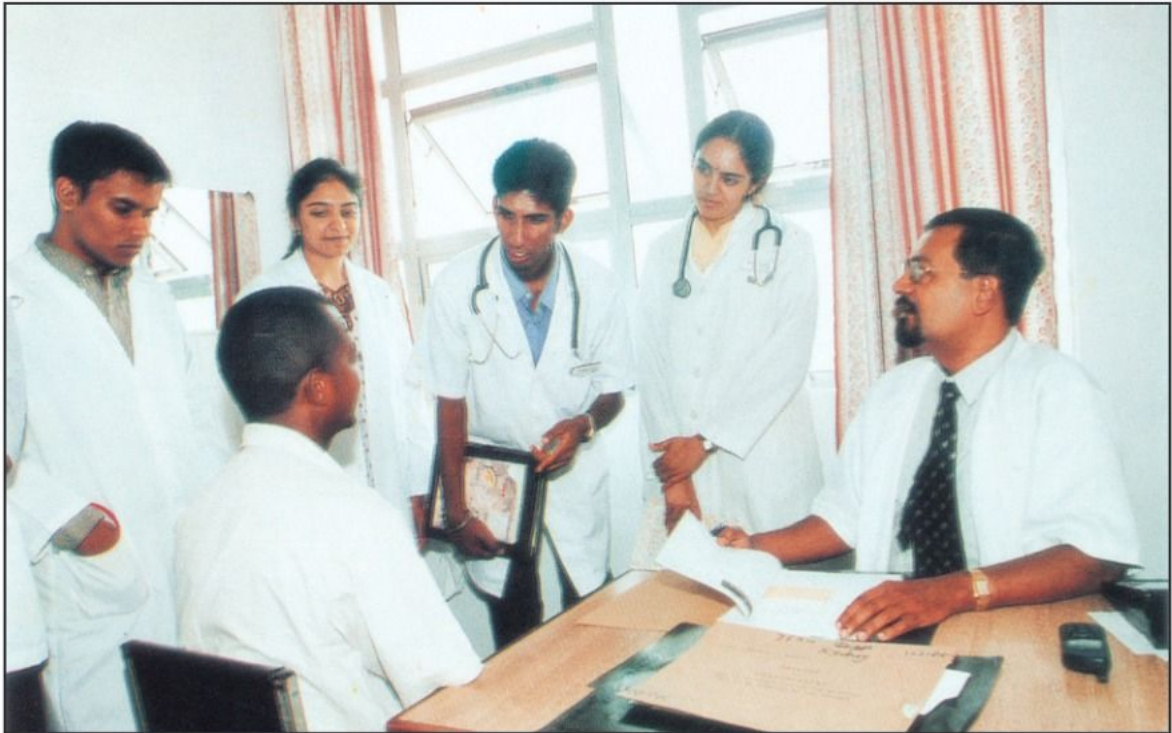

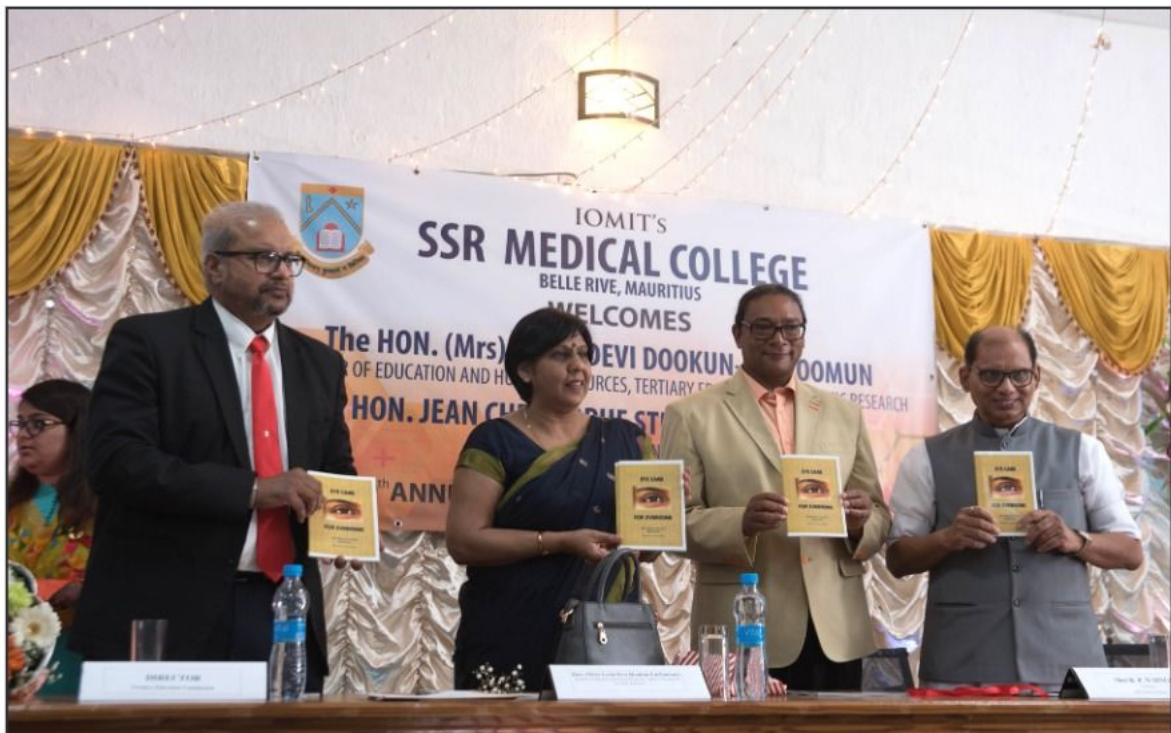

HISTORY:

The Indian Ocean Medical Institute Trust (IOMIT) was established in 1996 with the avid objective of promotion of education and learning and setting up a self-financed medical college in Mauritius in the name of the 'Father of the Nation' late Sir Seewoosagur Ramgoolam (SSR), who incidentally was a doctor also.

Mr. R.P.N.Singh, an educationist and social planner from India is the Founder Chairman and Managing Trustee of the Trust for Life.

The SSR Medical College was inaugurated on 18th Sept.1999 by Dr the Hon. Navinchandra Ramgoolam, Prime Minister of the Republic of Mauritius.

The SSR Medical College, operating for the last 26 years, with excellence is the first medical college of Mauritius. The College is situated almost in the middle of Mauritius near the central town of Curepipe about 15 km from the airport and same distance from the Capital city of Port Louis. The College is affiliated to the University of Mauritius, which is the degree awarding body. (Location of the College can be viewed on Google Maps).

They are working successfully in their respective countries and also in some of the most reputed hospitals in the USA, England, South Africa, Singapore and India etc.

One of our graduates may be practicing in your neighborhood and would be your best guide about life and quality of teaching at the S.S.R. Medical College & it is emphasized & implored that all applicant students & their parents must verify all or any information/ facts about the College from their own independent sources.

The SSR Medical College is spread over about 18 acres of land provided by the Government with buildings covering an area of about 2,50,000 sq.ft. housing the Pre-clinical, Para-clinical and Clinical departments.

The Ministry of Health and Quality of life has promised 'unflinching support' (See Hon. Health Minister's Commitment in Masseges) and provides state of the art J L Nehru, Victoria SSR and other specialty hospitals having more than 1000 beds for the clinical training of the students of the SSR Medical College. The MOH, Govt. of Mauritius has also agreed to arrange for the internship of our Indian medical students (vide its letter MHC / MCC / RG / FS dated 19th May 2024) as per the new rule introduced by the NMC, Govt. of India. The Medical Council Act 1999 of Mauritius has also been amended accordingly (vide Medical Council of Mauritius Letter No.: MCM/ADM/SSRMC dated 10th Nov. 2023).

The long cherished dream of our Chairman and like-minded people from India and Mauritius as well as the desire of the Mauritian people to have a medical college in Mauritius, has now become a reality with the active and avowed support of the Government and the people of Mauritius; which is developing as a medical education hub in the region.

Global RECOGNITION:

The MBBS degree of the SSR Medical College has been recognised by the Medical Council of Mauritius; the Medical Board of California, USA and the SSR Medical College has been recognised for listing in the IMED/ECFMG, USA, HPCSA; South Africa and the WHO. The listing can be viewed on the respective websites which enables our medical graduates to practice across the globe including in India; after completing local licentiate requirements (FMG Exam in India).

This enables our medical graduates to register and practice medicine across the world and specially in the USA and California, where recognition rules are the toughest. As a result, **Few hundred of our MBBS medial graduates are already practicing medicine in most reputed hospitals like Mt Sinai, Johns Hopkins's USA/ UK/ France, Canada, Ireland, Singapore and in many other developed countries.**

Recognition by the MCI:

As per regulations in India, any Indian citizen with a foreign medical graduate degree (FMG) has to pass the screening test "Exit Exam", held twice every year by the National Board of Examination, Govt of India.

The SSR Medical College graduates have the stellar/ **outstanding pass rate**, at this stringent MCI screening test, which speaks of the level of teaching and training at the College (Candidates' result at FMG exam would always be subject to individual performance). The list of almost all our graduates, who have cleared this test and are registered with the Medical Council of India can be viewed at our website (Alumni List).

The Country:

"Mauritius was made first and the paradise was copied after it" Mark Twain the famous American wrote in his book "Following the Equator". (More information available on Internet).

Mauritius is well connected by air with the major cities of the Indian Ocean Rim countries, Gulf (Dubai) and Europe. Air Mauritius flies direct twice a week from New Delhi and Chennai/Bangluru and thrice a week from Mumbai to Mauritius. Air Mauritius has always been a contributor in the developmental process of the nation. As such, it has taken a keen interest and provides the students of the SSR Medical College a discount on all Air Mauritius flights, which is subject to renewal annually. Emirate also has a very good connectivity from Hyderabad, Mumbai/ Delhi via Dubai.

The College:

The SSR Medical College is situated in the heart of this paradise in the picturesque former tea estate at Belle Rive. It is spread over about 20 acres of tea garden land and is criss-crossed by two natural rivulets flowing through it. Teaching blocks, canteen and facilities are situated and planned in phases on the right flank of the rivulet where as residential blocks, Cafeteria auditorium, squash court and hostels are built & planned on the left flank of the rivulet. The on-the-campus ladies' and gent's hostels are planned separately though quite near to each other.

The Campus:

The existing building housing the Pre-clinical and Para-clinical departments has a floor area of about 2,50,000 sq. ft. Each department has its separate seminar and demonstration rooms along with a museum as required by the various Medical Councils. The department of anatomy has a spacious dissection hall of 5000sq. ft. (Sufficient number of **cadavers** are available in anatomy dissection hall) with all modern equipment and facilities for all the three types of dissection : real, virtual (Multimedia) and artificial (Dummies). All the departments are provided with charts, models, well planned museums and modern audio-visual educational aid & equipment, slide and multimedia projectors. In addition to the conventional lecture theaters, special darkroom type mini lecture theatres are provided for multimedia/computer assisted special audiovisual teaching supported by excellent clinical training facility including an air conditioned "Clinical Skills Lab" of International standards. The whole campus and the residences are covered by "Wi-Fi" connectivity. **Prof. (Dr.) Paul O' Neil, Associate Dean, Medical Education, University of Manchester, UK on his inspection visit to the college has recorded "I have been very impressed with what I have seen".**

The Cyber Library:

The well-stocked airconditioned library is equipped with all recent books and current journals. The Cyber Library of the SSR Medical College was inaugurated on 7th March 2000 by **Hon. Smt. Vasundhara Raje**, Minister from India on the eve of the visit of the Indian Prime Minister, Shri. Atal Behari Vajpayee to Mauritius. Now there are 4 Cyber Libraries Catering to the needs of the senior students, junior students & faculty members separately. 50 independent terminals have been provided, which are connected to the Internet and follow the open access system thus providing an added incentive & opportunity to the students. The library is kept open on all working days from 08:00 hrs to 16:00hrs. However, the reading rooms are open up to 22:00 hours, as per student's needs.

A unique feature of the Cyber Library is its access to about 250 global medical journals to keep the students abreast with the latest in the field of medical research and development which can be viewed through the links e-journal on our website www.ssrmedicalcollege.com. The students are provided with facility to download and print the relevant material for nominal charge.

The SSR Medical College follows the curriculum based on the latest guidelines laid down by the Medical Council of India incorporating certain features like Medical Informatics from the General Medical Council of UK.

In keeping with time, a unique feature of the syllabus of the SSR Medical College is a module on Information Technology and communication skills. This module has been included in the MBBS 1st year curriculum along with the pre-clinical subjects so that a student of the SSR Medical College is fully conversant with modern information technology skills before entering into the para-clinical years and is capable of communicating with the medico-education world independently and is induced in the process of self-learning. In teaching, emphasis is more on "feel and facilitate" rather than on traditional method of "chalk and talk".

With a view to imbibe a sense of discipline, responsibility and uniformity, it has been decided that the students of the 1st year MBBS must come to the college in uniform. **Smoking and consuming alcohol are strictly prohibited on the campus and any student found indulging in such or any other activities unbecoming of a student would face strict disciplinary action, which may lead to expulsion also and the decision of the SSR Medical College authorities in this regard would be final.**

Hostels:

To insulate the students from probable exogenous evil influences, all the overseas students are required to stay in the hostel & to be a member of the mess at the campus. Separate accommodation is provided for the Ladies & Gentlemen, with attached toilet and bath with hot water geyser facility. The students are provided with double sharing rooms. This has been done with a view to avoid loneliness, which a student encounters when he is away from home for the first time. The residents are provided access to e-mail facility at nominal cost to remain in touch with their family and friends. All the residences are covered by "Wi-Fi" connectivity and the student can use their compatible laptops/devices from their rooms. Installation of an ATM at the campus is also underway. All hostel residents must observe the "Rules for Hostel Residents" made in this regard by the college and circulated through the notice board.

The college has on the campus canteen and mess facility to cater to the varied dietary requirements of variety of overseas students from about 14 countries. The Mess charges are to be paid directly to the mess operator. A modest living excluding the room charges, in the hostel would cost about US\$ 100 per month. **Lest it will damage the electrical wiring and may cause short circuit & fire; as a safety measure, cooking and use of electrical gadgets in the hostel rooms is strictly prohibited & is a punishable offence.**

Free college transport is provided to ferry the students from the college to the hospitals and for recreational trip to market on Saturdays and pre-planned tours approved by the Principal, on holidays. A senior faculty member is in charge of every group of 15 students and can be contacted directly by the parents to inquire about the development of their ward. There are periodical reviews of the teacher-taught relationship at the highest level and the students have direct access to the Principal and the Chairman for their problem. So long as they fulfill their duties and obligations towards their studies, they will find the college a home away from home.

Hostel accommodation at the campus is available for about 80% of the students and will be allotted on first-cum basis to be confirmed by payment of the hostel registration fee. Hostel facility once opted for and registration fee paid to the college for hostel facility is non-refundable even after withdrawal from the hostel facility. Any student opting out of the hostel must inform in writing to the supt / warden and college office, at least 6 months in advance; or else hostel fee for the full year will be charged.

Clinical Training:

It is essential for a Medical College to have a hospital attached to it for the clinical training of the students. The students of the SSR Medical College are provided clinical training in Jawahar Lal Nehru, SSR and Victoria and other specialty hospitals of the Government of Mauritius having more than 2000 beds with state-of-the art facilities. A firm commitment has already been obtained from the Ministry of Health, Government of Mauritius for the training of our students in these government hospitals. The existing facilities at these hospitals satisfy the training norms laid down by the Medical Councils. The clinicians of these hospitals are also involved in imparting clinical training to the students of the SSR Medical College under the supervision of the unit heads of the specialties. All these hospitals are equipped with instruments and equipment of the highest global standards and will give the right kind of exposure and training to the medical students of the SSR Medical College thus helping to **produce doctors for the new millennium.**

The IAC is a revolving body, comprising of the renowned personalities in the field of medical education and periodically and regularly advises on the quality of the education and staff at the SSR Medical College in consonance with the University of Mauritius and the Indian Ocean Medical Institute Trust.

WHO & ECFMG, USA Recognition:

The SSRMC has been recognised for listing by the WHO vide letter no. OSD-E3/374/5 dated 12th Dec'03 & also by ECFMG of USA for listing in the IMED, which can be viewed through links available on www.ecfm.org. This recognition enables our students to take the USMLE part I & II in Mauritius itself. The WHO listing can be viewed on WHO website.

Medical Council Approval:

The Medical Council of Mauritius has already recognised the MBBS course and approved P.G. course of the SSR Medical College. The Syllabus of the SSR Medical College is based on the latest guidelines of the Medical Council of India with additional features like Information Technology from General Medical Council of U.K. The MBBS course, infrastructure and the facilities have been set up keeping in view the requirements of the Medical Councils. The teaching hospitals have sufficient numbers of beds and facilities as per the norms of the MCI. Recognition from the **Medical Council of India** will be in accordance with the Govt. of India, Ministry of Health & Family Welfare letter no. V. 11016/15/99-ME (OG) dated 24th March 2000.

The M.C.I. letter stipulates a screening test / "EXIT EXAM" for all the overseas medical degree holders, which now **has been made mandatory for all**, as per the new legislation of the Govt. of India. (Please check latest guidelines from NMC website in this regard).

It is a testimony to our quality teaching & training that most of the students graduating from the college have already cleared this "Screening Test". SSR Medical College is the only college to post such outstanding success at the Screening Test held by the National Board of Examination, Govt. of India and our graduates have got placements in Hospitals like Mt. Sinai & Johns Hopkins, New York, John Stroger, Chicago, USA and Kings Mill Hospital, UK. The list of our graduates is available on our website.

Registration with the **Medical and Dental Professional Board / Health Professions Council of South Africa** will be in accordance with their Letter dated 11th Nov. 2024 upon successful completion of the Medical Board Exam & letter no. 2/14/18 Mr. L.A.Henderson X232/ mmt dated 11th October, 99 & in term of "Department of Health-Policy on Recruitment, employment and support of Foreign Health Professionals in the **Republic of South Africa - Internship** Para 5.6.1.4", which provides for internship allocation to 'Final-year medical students from SADC countries, e.g Lesotho, Swaziland, Mauritius, Botswana, etc. Each case will be considered on merit.'. The approval from the **Royal Medical Council of Nepal**, the **Malaysian Medical Council** and Sri Lanka & Bangladesh is also in process. However, most of the countries require a foreign medical degree holder **to pass a Screening Test before registration** for medical practice.

Internship and P.G.:

Internship options have been worked out 'in principle' at a 700 beds hospital in Delhi and would be available to our graduates at various hospitals across India on merit basis, subject to local regulations. Moreover, the Medical Council Act 1999 of Mauritius has been amended (Vide MCM letter no. MCM/ADM/SSRMC dated 10th Nov. 2023) which enables non-citizens who have been awarded MBBS Degree by the University of Mauritius to undertake their Pre-Registration Training (Internship) in Mauritius. The process for starting the PG courses in selected 16 specialties namely (1. Anesthesiology & Critical Care, 2. Internal Medicine, 3. Ophthalmology, 4. Radiodiagnosis, 5. Surgery, 6. Pediatrics, 7. Psychiatry, 8. Dermatology, 9. Pulmonary Medicine, 10. Pathology, 11. Orthopedics, 12. Obstetrics & Gynaecology) and Non-Clinical disciplines (13. Anatomy, 14. Physiology, 15. Biochemistry and 16. Pharmacology) has already been initiated and these PG Courses are likely to start at the college soon i.e. by September 2026.

The management of the SSR Medical College is fully aware of the challenges as well as opportunities of opening the first medical college in Mauritius. As such, the Chairman has laid down a policy of taking only the young, energetic and the best faculty with international exposure and profound academic experience.

The faculty of the college has been selected from teachers graduated and teaching at the most reputed institutions like Oxford, the All India Institute of Medical Sciences (AIIMS) Delhi, PGIs, Armed Forces Medical College, Pune, JIPMER, Pondicherry, St. John's Medical College, Bangalore, University of Hong Kong and other reputed institutions. It speaks of the promise and prestige of the SSR Medical College that the reputed faculty from such institutions have applied and opted to work with us.

Duration of the M.B.B.S. & Post Graduate (M.S./M.D.) courses:

The duration of the MBBS course is 5 years (Full time-Didactic & In-ward/ bedside teaching/ training in English medium); divided into 10 semesters of 6 months each from the date of commencement of the course. The MBBS course is followed by compulsory Rotating Internship. The period of 5 years MBBS course is divided into 3 phases.

MBBS Phase I (I to III Semesters), Phase II (IV to VI Semesters), Phase III (VII to X Semesters)

Post Graduation : 3 years (Full time-Didactic & In-ward/ Bedside teaching/ training) in English medium.

University Examination:

The University of Mauritius appoints external examiners and moderators of international repute for conducting examinations at the end of each phase. Eminent Academics like **Prof. Eric Harley**, MD, Ph.D., F.R.C. Path., (UK) of the University of Cape Town, South Africa, **Prof. Peter Gray**, MD, Ph.D. F.R.C. Path., (Cambridge) of the University of North Durham, U.K. etc. had been the examination coordinator for the University Examinations in the past.

They are assisted by renowned MCI & DCI approved External Examiners from reputed Indian Institutions like Lady Hardinge, University College of Medical Sciences Delhi, St. John's Medical College, Bangalore & KGMU, Lucknow etc.

Examination consists of Theory, Practical and Viva voce. **An examination fee @ US\$100 per subject** shall be payable by the candidates for appearing in the University Exams for regular as well as resit exam. For any delay in filling & submitting the "Exam Form", a late fee of MRs 2500/- will be charged.

Rules of Attendance/ Internal Assessments (I. A.) and Examination:

To maintain the high standard of medical education, the college/ University of Mauritius requires every student to **complete the MBBS course in given time and attempts (check latest prevailing rule) e.g. in 9 years of time, availing 4 regular and 4 extra attempts** for the University Examinations to be conducted at the end of the 3rd, 6th, 8th and 10th Semesters. However, all the students are required to pass the 1st Professional University Examination (at the end of the 3rd Semester), in maximum of 2 extra attempts in addition to the one regular attempt; i.e. in total-3 attempts; **failing which the student shall be "de-registered" from the MBBS Course.**

Candidates who fail in the 1st professional examination will not be allowed to enter Phase II. The candidate shall pass all Phase II subjects before appearing in exam for Phase III subjects. After the Phase III Final Professional examination, successful candidates have to undergo one-year (as per rules) compulsory rotating internship. 80% Physical attendance in Theory classes and Practical classes and 40% marks in Theory and Practical classes and in Internal Assessment (I.A.); which includes Monthly Tests, Seminars and Semester Exams including 'Pre-University Exams' which are also an integral part of internal assessments (Summative assessments) & day to day (Formative assessments); will be necessary for eligibility to appear in each University Examination. **Absence from the course/ classes continuously for 15 days without proper written sanction of leave from the Principal/Chairman of the Institution shall be treated as leaving/dropping out from the course.** Additional Term tuition fee is to be paid for studying 6 months extra, if the student fails and repeats the term. Since all the students are 'adults'; it is Mandated/ expected that they shall keep a strict watch on their attendance & academic performances in all tests & exams &

shall share/ keep their parents/ guardians aware of the same directly. No such personal information will be shared/ sent by the college authorities with anyone; except the concerned student. Any kind of direct or indirect effort to influence the exams or results of a student by him/ her parents/ relatives or friends will be viewed very seriously & liable for strict disciplinary action against such student; which may lead to suspension & expulsion from the College. Any student found copying or cheating; even using phone / any electronic device in any of the exams (Internal Assessments, Pre-university exams or University exams) will be liable for serious disciplinary action in addition that he/ she will be given "0" (Zero) marks in that paper, where he/ she has been caught cheating/ copying. Report of the Exams Invigilator/ Exams Supritendent/ Principal will be final evidence of cheating or copying in the exams.

Commencement of the Courses:

The intake is twice per year wef. September 2017 (In September & in March). **The induction courses of 2 weeks for the overseas students are scheduled for 2nd Monday of September and again for 2nd Monday of March respectively every year.** Vacations are planned every year, in the month of December/ January/ & June. (For details see College Calendar on College Notice Board).

Admissions:

1. Eligibility for Admission:

i) Academic:

A: For M.B.B.S. - Candidates should have passed the 10+2 (XII) / A level or an equivalent examination from a recognized board with Chemistry, Biology, Physics / Maths and / or English as principal subjects.(Subject to latest guidelines of the college / U o M) Candidates seeking admission in MBBS Course should have obtained not less than 60% marks in class 12th or 21 points at A Level (A=10:B=9:C=7) respectively in each subject as the minimum requirement. However, only candidates having more than 70% marks in class XII stand a fair chance for selection. Indian students should have passed the NEET exam also **in any year.**

B: For Post Graduate M.S./ M.D. - M.B.B.S. or equivalent + 3 years medical practice post M.B.B.S.

ii) Nativity:

Students from Mauritius as well as other countries are eligible to apply. The candidates should have proficiency in English.

iii) Age:

Candidate should have completed 17 years of age on 31st Dec. 2026. They should submit documents like birth certificate or school leaving certificate to prove their age.

2. Rules of Admission:

i) Application Form:

A candidate for admission must submit an application in his own handwriting, in prescribed Application Form, which has been duly signed and issued by the Chairman & Managing Trustee of the IOMIT. The Application Forms can be obtained from Registered office at Mauritius, Command office at New Delhi or from designated area centres/offices mentioned in the prospectus. This form, duly completed in all respect along with necessary documents, must be submitted either by Registered post or handed over personally together with stamped and self-addressed envelope for a reply, so as to reach the office of the Indian Ocean Medical Institute Trust before the last date. Incomplete, defective and late applications will not be considered and no correspondence in this matter will be entertained. Mere submission of application and payment of processing fees or "Registration Fee" towards 'Provisional Offer of a seat in the course' will not create any right or interest in favour of the said applicant for admission to the course and the SSR Medical College.

Provisional application for admission can also be made electronically through our website www.ssrmedicalcollege.com, [icon: "admission form"](#); sharing a screen shot of the duly filled up admission form on our e-mail; which is to be followed by the hard copy of the duly filled "admission application form" given at the end of this brochure.

ii) Certificates/ documents to be attached to Application Form:

- (b) Pass certificate/ Mark List of qualifying examination (10+2/A level or equivalent)/ copy of NEET result & M.B.B.S. or equivalent mark list in case of application for Post Graduate (M.S./ M.D.)
- (c) Conduct certificate from the Head of the Institution.
- (d) Document to prove age
- (e) Medical Certificate from a Registered Medical Practitioner as to the candidate's physical fitness to undergo the course
- (f) Self addressed & stamped envelope size (9½" x 4½")

iii) Selection of Candidates:

Selection will be based on merit, taking also into consideration the applicant's capability to meet the financial requirements of an overseas education (support by Bank Statement for the last 6 months and a letter of commitment from the Parent) and to contribute towards the growth of the institution. Short listed candidates may be required to appear for an interview before the **"Admission Panel"** headed by the Chairman on the given date and venue which will be intimated later, at their own expenses. Selected candidates will have to pay the required fee before the admission by D.D. / T.T. in favour of "Indian Ocean Medical Institute Trust".

iv) Cancellation of Admission:

If any candidate who is offered admission does not pay the prescribed fees at the time of admission, his admission will be treated as cancelled and the seat will be offered to the next eligible candidate. Mere presentation of a Bank Draft towards Registration fee/Tuition fee, unless the same is accepted by the College and the due Receipt is issued by the college, will not create or confer any right or interest in favour of the applicant for admission to the MBBS Course at the SSR Medical College. The IOMIT/College will not be responsible for any postal delay or delay due to any other cause in the receipt of the notification of admission of the candidate.

The admission offered to the candidate shall be cancelled if later the IOMIT finds that the candidate is not eligible for admission **due to non-fulfillment of the any of the conditions of admission & any fee paid by the candidate will not be refunded.**

Even if a candidate has paid the fees but fails to join the college within a fortnight without intimation or prior permission of the Principal, the latter may at his discretion cancel the admission of such a student. **If any student after accepting Provisional admission or paying the registration fee leaves or drops out of the course due to any reason; any fee including registration fee paid by the student shall not be refunded.**

If any information supplied by the student in connection with his admission is later at any time found to be incorrect, the student shall be liable to be removed from the College and all the fees paid by him shall be forfeited. The decision of the Management i.e. IOMIT in this regard shall be final.

The Chairman of the Indian Ocean Medical Institute Trust reserves absolute right to reject all or any of the applications without assigning any reason at any time before a candidate has formally joined the course at the IOMIT's SSR Medical College, Mauritius.

v) Execution of Agreement:

The Parent/Guardian of the student admitted to the SSR Medical College shall be required to execute an agreement in the proforma attached herewith at the time of admission of the student/ward to this college.

vi) Important Notice:

- (a) The Fee is to be paid only by D.D. or T.T. in the name of "Indian Ocean Medical Institute Trust". Any payment for less than US \$ 2000 shall have to be made by T.T. only.
- (b) **We do not have any Recruiting Agent or Body Representing us.** Any body dealing with any such agent will be doing so at his own risk & peril and Management will not be responsible for any such action.
- (c) Since all the students are adults, their parents are expected to gather all information about their performance/ attendance etc. directly from the students.
- (d) This prospectus is only for providing information and it is not a legal document to form basis for any claim by the applicants.

3. Tuition & Other Fees

MBBS:-

College fees is payable as prescribed by the Indian Ocean Medical Institute Trust from time to time. However, if the fees for the full course of 5 years is paid upfront by any student at the time of admission, he/she shall be given a discount of 20% in the fee. Moreover, he/she will not be affected by any subsequent increase in the fees. As such, he/she will not be required to pay the increased amount of fees. **Examination fee @ US\$100 per subject will be payable in addition to the fee.** Due to steep rise in US\$, the fees for MBBS Course for the year **2026-2027** is as follows:

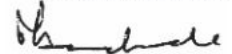
Attention is invited to your letter dated 23rd December, 1999 addressed to the Ministry of Health & F.W. and your letter dated the 29th May, 2000 addressed to this Council on the subject mentioned above. The contents of World Federation for Medical Education (WFME) Task Force on 'Defining International Standards in Basic Medical Education' (report from the working group) have been noted.

As regards, approval of the syllabus of SSR Medical College, Mauritius, it may be pointed out that the Medical Council of India does not approve the syllabus of any foreign medical institution. It is however noted that the ingredients of the Graduate Medical Education Regulations, 1997 of this Council have been incorporated in the syllabus of SSR Medical College, Mauritius except a few amendments recently made. We are however sending herewith a copy each of the following documents for your information:-

1. Graduate Medical Education Regulations, 1997 with amendments.
2. Establishment of Medical College Regulations, 1999.
3. Minimum Standard Requirements for the medical college for 100 admissions annually Regulations, 1999.

The question of recognition of the qualification granted by this college/university can be taken up only after the first batch of students appear for the final examination and are awarded degrees by the University and if a request for recognition is made by the purpose by the Govt. of Mauritius to the Govt. of India. It may however be pointed out that the Govt. of India is considering a proposal to hold a screening test for all Indian citizens obtaining foreign medical qualifications for the purpose of registration in India.

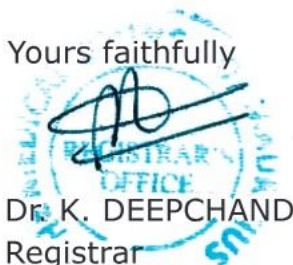

 - In case of the student/ guardian failing to pay any fee due to any reason, in due time ie 31st January of the concerned year, the student/ guardian agrees:
 - To pay a late fee payment charge of US \$ 500/- (US\$ Five Hundred only), if the due fee is paid by 31st March of the said year; and a late fee payment charge of US\$ 1000/- (US\$ One Thousand Only), if the due fee is paid by 31st December of the said year.
 - Any delay of more than this period in paying the due fee shall attract a late fee payment charge of US\$ 2000/-.
